


#### **CONFIRMED NOTES OF THE 59th MEETING OF THE UK NATIONAL AEROSPACE NDT BOARD**

There was also a lengthy conversation regarding this document and items that Alan Parsons has brought up. The rest of the changes to this document were looked at, discussed, slightly amended and approved.

#### 6. Qualifying Agencies

#### a. Oversight Matrix

The matrix was tabled.

JB stated that Alan Parsons would need to be witnessed this year and AW stated that he would be able to witness Alan on 18/19 October at Lavenders.

Clive Hammond also needs to be witnessed and PB stated he would be able to witness Clive on 25/26 September at South West School.

TG confirmed that she would inform Tara Ashton of this upon her return to the office.

#### 7. EN4179:2017

JB stated that this is now published. JB stated that when the standard was published by CEN it goes to the member states on the ballot. When it entered the UK, this was not seen and the UK abstained from voting. The next time the new standard is released, it will now go to a newly created group in Domain 4 and working group 15. The Chair of this WG is Chris Stevenson who works for Rolls Royce and the idea is that if there are any standards coming out of CEN, will be dealt with by this working group, who will make sure it is distributed to the correct people. This is any NDT standard, not just 4179. JB stated that if anybody wants to be part of this working group, they should contact Chris Stevenson.

Action 03/2016 – this was an action on JD to form a working group to look at experience within E4179. The working group had dealt with this action and the working group are happy with what has been prepared, this now needs to go around the rest of the Board and then to be taken to the European Forum and also to the sub-committee at AIA.

# Action 19/2017 – TG to circulate the document prepared by the working group with any comments to JD by 31 July and then this will be put forward at the September meeting for vote

JD also stated that there was an action 09/2017 which was to review the 4179 and the NANDTB documents for future changes for NANDTB documents in the future.

#### 8. ANDTBF (JB)

a. In May there was a meeting of the ANDTBF which was hosted by the CAA at Aviation House. The first day a number of people attended with the intention to create an audit checklist for auditing Aerospace Boards. JB stated that the checklist isn't yet finalised, however when completed, each Aerospace Board will audit themselves against the checklist. The checklist will then be submitted to BINDT. Any Aerospace Board that does not comply with the requirements can no longer be a member of the forum, they can attend the meetings, but they will have co-opted status. Anyone who does comply will remain as a voting member. There was also a proposal that the NANDTBs are then audited on a periodic basis by the National Aviation Authority with the checklist that has been defined. From this meeting it was established how different Boards operate and the primes expressed concerns about the second proposal and Italy confirmed that they may employ independent contractors to review the Italian Board.

There was also a NADCAP meeting that took place and there was an extension to this meeting which took place to discuss the Outside Agency Accreditation Program.

JB then went through a PowerPoint presentation that had been presented at the NADCAP meeting.

A lengthy discussion took place regarding this subject and as a result, JB suggested that a working group is put together to work on the checklist.

#### Action 20/2017 – A working group consisting of BS, MCI and JB will review the checklist

JB also stated that the procedure drafted for the basis exam, UK was the only country to accept this. Another draft will be prepared that is based on the language in 9712 and JB is to draft this.

The proposal from the Swiss Board about standardising the maintenance review was agreed and it will be turned in to a procedure and at the next meeting, hopefully this will be accepted. UK stated that we would like this to be a guidance document rather than being mandated.

#### 9. Pt. 145 Orgs and SIG members Update – (GMcC)

GMcC stated that TB is going to provide GMcC a list of organisations and then BF will help with guidance with a letter to go out

#### 10. Regulators Update – (TB)

GR23 is now a Word document to be circulated.

#### 11. OA/IA Group

MCI stated that regarding specific theory exams since have been changed to interpretive format. There are two aspects, the first one is that for a new candidate there is no impact, however for a recert candidate there is a higher failure rate, this is not just SWS, but this is across industry and this is because candidates have not seen exams like this before, 5 years ago they were not open book interpretative, they were either straightforward open book or they were closed book. The other aspect is that exams are taking much, much longer to complete and there are differing approaches from the Outside Agencies about how to deal with this. There is nothing in 4179 that governs times for specific theory exams and the Board may need to deal with this.

A lengthy discussion took place regarding this.

Action 21/2017 – MCI will gather some figures regarding the pass rate/non pass rate or candidates for the specific theory exam
