CS also stated they are looking for someone else who may be interested in sitting on the WG. CS did state that an OEM should be a convener for WG15 – any nominees to be sent to CS.

8. ANDTBF (JB)

a. ANDTBF_08 adherence by other boards

MC would like the support of the Board to attend the next meeting in conjunction with the representative of the Board.

SWS are finding that the Singaporean NANDTB are refusing to allow agencies not accredited by themselves to give training in Singapore. This is not in line with document 08 of the forum. They would like to try and get the Singaporean Board to comply with document 08.

There were no objections to SWS pushing the matter.

MC will also send NC an email with the issues SWS are experiencing and he will see if there is anything he can do.

NC did not think that Singaporean Board were given the full support of EASA as of yet.

MC will write to NC in the first instance to respond on behalf of the CAA and if SWS need to attend with Jon B at the next meeting to raise this question of membership of the federation, if they are not adhering to the rules.

NC did state that the SWS can be used, however have been informed by members of the Board that they cannot be used.

b. ANDTBF_14 & NADCAP AC7114-11 harmonisation

The Boards were asked to self audit, not all of the have done this yet, anybody who had not will lose their voting rights and become Observer status only.

PF has requested sitting on the NANDTB and has requested to sit on the ANDTBF to ensure that document 14 remains the same. The reason is that the NADCP AC7114-11 is based and written around document 14. Everything that the NDT task group have agreed to is based around that document and PF is worried that if 14 now changes slightly/dramatically, the task group could state that changes are not agreeable and this is to keep the two document harmonised.

10. Regulators Update - (NC)

EASA have been quiet on the issue, however the CAA have approached EASA asking for whatever the event that would EASA continue to recognise the UK Board. They have stated that because the Board is accredited and is aligned with ANDTBF_08, they are intermating that they would recognise the UK Board. They have not however stated this fully. The UK CAA are talking with EASA and they are wanting to create a working arrangement. There was a meeting last week and one of the things that was going to be put forward for the working agreement is mutual and mutual recognition of the UK Board and what is in place.

There are discussions at the moment and the UK Board have been accredited and they are a member of the European Forum and it will be accepted.

In the event of a deal EASA have stated that there will be a two-year transition where nothing will change. The working arrangement is designed for a no deal scenario.

There are bilaterals in agreement between various parties for mutual acceptance.

NC had not yet received any feedback from the meeting.
