During and audit carried out by BINDT an issue was raised about the NANDTB's confidentiality around personal information that is looked at and that is circulated to the Audit Review Team.

AP and Alicia Carroll from BINDT have drafted a GDPR form that everybody at the meeting is to sign for AC to hold. For those not at the meeting, KP will send the GDPR forms for signature.

- d. NANDTB_12 Following an audit report that was received by the Audit team, they had an issue with how a method L3 had been qualified. If you become the RL3 have you been external to be examined?

Discussion taking place regarding the above, the Level 3 in the case concerned, came up through the ranks, was internally examined by the RL3, it doesn't appear through the paperwork trail that he has then at first rectification as he has recertified by points to have gone independently. No external examinations appear to have been taken.

AW asked if the new RL3 should undergo exams at an independent OA as opposed to going through the points system.

SW stated that he had this when he renewed his qualification as his qualifications had been done at AIT originally and then they took over AIT which created a problem as initially he had been examined independently.

AWs issue is that the new RL3, however it looked like the initial L3s were overseen by the previous RL3, he did not appear to have taken any L3 exams at an independently approved OA.

Does there need to be a specific statement stating that if someone is internally promoted to RL3 status, does there need to be a specific statement that states that at the next requalification someone must go and be examined externally by exam. Discussion taking place regarding this.

If someone is promoted from within then an external qualification by points is not acceptable.

When an RL3 is appointed, they are re-qualified within the first 6 month period.

NANDTB_12 does not need to be changed to reflect this.

A WG session took place the day before the meeting. As this document is currently being used, another new document will be created to cover new products and processes.

TG tabled the NANDTB_29 with KP going through the changes.

6. Qualifying Agencies

a. Auditor Oversight, review matrix

Andy Kular is currently carrying out audits. AK is currently doing his two overseeing audit. He has done his shadow audit, he has got one to do on his own and next year he will be overseen doing an internal and external audit.

Each auditor should be covered on an inside/outside. If Nadcap are in China and Xiamen is scheduled for January/February time is there anybody going to NADCAP that could oversee this audit? Nobody was going to NADCAP from the room.

7. Standard Review

a. prEN4179

At the last meeting Chris Stevenson went through all the changes for 4179. All the comments were forwarded to WG15. WG15 is currently without a leader and if a UK OEM stepped up to be on that group, can someone from the Board sit on it?

ADS meeting was discussed and the need for this to be invigorated.

Andy Bakewell had an action in the minutes for ADS to raise awareness of the NDT Sig and highlighting its value to primes etc. KP is not sure whether this has been done.

KP stated that he would try and get a teleconference going on with then.

prEN4179 is expected to be released around January/February time. This will be a pr version, when it gets released fully the Board will need to release an advisory to the NDT community. The pr document will be released for 6 months so in September/October time EN4179 2020 will be published.

As soon as the pr document is live and advisory will be put on the website.

NADCAP will also release a new checklist.

8. ANDTBF (JB)

In November there was a Forum meeting at Safran in France. UK dialed in and Michelle Clapham was made very welcome.

The Forum has a new Chair Helmuth Hoeller. HH's message from the meeting was that if you have any complaints about anything, then you should turn up to the meeting. There is also a new rule that if you are not present at more than two consecutive meetings you will lose your member status and you will become an observer and you will have to reapply showing evidence of adherence to all the Forum document and seek Board approval to regain your member status and voting rights.

They have now implemented ANDTBF_08 and voting rights have been removed from those Boards

who have not completed sufficient independent self-audits or have become accredited to AC7114-11. Carmen Chirita stated that all OAs should be approved under the same standards and there should be a common checklist.

Because of Singapore not adhering to document ANDTBF_08, MC attended the meeting and gave a presentation explaining the history/reason. The majority of the people preset would recognise approval status granted by the UK Board but the agencies will need to be on the approved list of the Aerospace Boards for countries in which they operate.

E.g. SWS who operate in Finland will need to submit a request to the Finnish Board to be on their approval list. Each agency will need to go through the countries in which they operate to get added to their approval lists.

Carmen also stated that she would like to see OAs approved to the same standard under approved Boards, UK would like to be involved, Switzerland, Portugal and either Norway or Denmark to work on the checklist. MC suggested that the checklist the UK use may be a good starting point. Phil Ford suggested that he would like to also be on this WG.

UK Board have 2 seats at the ANDTBF, there needs to be a plan of who can attend. The next meeting is at Russia. MC is happy to take the second seat until something is resolved for attendance. It needs to be a full member of the UK Board or an observer.

Take back to the OA/IAs about adding a levy fee to the audit fees in order that this money can fund the activities of the UK NANDTB.

Action 38/2019 – MC to take back to the OA/IA about charging extra levy to fund activities of the Board

9. Part 145 Orgs and SIG's – Input (GMcC)

GMcC stated there is nothing to report.

10. Regulators Update – (NC)

KP has received an email from NC.

Our NADCAP certificate should have a higher profile on our website, move Certificate.

Action 39/2019 – TG speak to David Gilbert about moving the certificate to front page of website

EASA are chasing the Regulators to find out the status of their Boards. The CAA have asked the UK NANDTB to provide that we had no findings and confirm the checklist the Board work to. As there were no findings, the Board could not provide a copy of this.

11. OA/IA Group (MC)

There are no issues to raise, everybody is waiting for Brexit.

The L3 basic was discussed at the Forum and they are minded to keep the requirement under ANDTBF_10.

Regarding the recertification under the points system, the RL3 documentation is sent to the OA/IA for review. KP stated that only the endorsements are being made.

When the auditors audit is the L3 paperwork looked at?

During the next review the checklist it was noted that refresher training in the event of failing the exam and the OA requirement according to the checklist is to confirm the training being given. Is it the duty

of the OA to second guess the RL3?

PCN Aero is due to come out on 1 February with implementation on 1 May. BINDT are waiting to hear from NC and his team about whether PCN Aero is acceptable to the CAA.

12. Funding for the PRI AC7114/11 audit of the UK NANDTB (KP)

KP to write to Safran about payment of their invoice.

13. Any other business

a. NANDTB_03

Whilst KP was reviewing the above, in accordance with clause 7, 8 and 9, the Chair, Vice Chair and Secretariat need to be voted on.

Chair – KP stated that he is happy to stay on for another 2 years;

Vice Chair – AW is currently our VC;

Secretariat - a vote taking place regarding this - happy for BINDT to remain a Secretariat

b. Direct Observation

PB has been looking at the definition in the standard.

NADCAPs interpretation of direct observation is the job someone is doing must be 100% observable, i.e. if they are looking at UT screen, the supervisor should observe the screen for the whole of the time.

Direction observation from 2017 is which the observer is able to come to the immediate aid of the trainee and remains within a distance that permits uninterrupted, unaided visual and verbal contact with the trainee.

From 2019, where the observer is able to review the NDT process in uninterrupted visual way with two-way contact with the trainee.

Discussion taking place regarding this – you need to be able to see the person.

It was noted there should be guidance notes.
