10. NADCAP Update

a. Update from Nadcap community to ensure alignment

AC7114/11 – checklist that the Forum/Board use to ensure the Boards are controlled. Been through ballot no changes. The reason for PF being here is to aid the understanding of what is going on with the checklist.

UK, France, Japan, China and Spain - close, Italy have a waiver that finishes this year.

Austria will not be applying and Australia are still undecided.

NDT task group looking at examination centers and they were looking at companies primarily in the US. The task group aims to generate an audit criteria (extra checklist) to look at the exam process which would give them an independent accreditation as some boards have also stated they will not be applying for /11 accreditation. Once NADCAP have agreed the checklist they will propose to the Forum and also EASA for acceptance.
