Concerns: Jes D contacted EM Inspection with regard to EM's asking for what was thought to be

unnecessary personal information. EM's James Bakewell indicated that where the Board thought the requirements to provided personal information was in excess, then they would be prepared to review the current document download/generation procedure for Tumbling E.

Jes D also indicated that a tick box approach would be preferred and that If asking for personal information then a disclosure statement needs to be put on EM Inspections website, after a discussion it was noted that there is an issue about GDPR. b. New documents

Remote NDE - current status and next steps NANDTB_29

A document has been created ready for issue, needs to be voted on. Feedback through January was received, some minor changes were made, and the documents circulated on 1 February 2022.

Document voted upon – no objections, document accepted - GL and PW to present at The BINDT Aerospace event April 2022.

An article from GL/PW will be drafted for inclusion within the June issue of NDT News.

6. Qualification of XCT personnel Working group

It was confirmed that a working group should discuss objectives, terms of reference, seek volunteers/interested parties from main stakeholder groups (primes, training agencies, BINDT, CAA/MAA, equipment manufacturers)

A date for the first WG session should then be confirmed by KP

The WG should look at requirements confirming how persons are trained and approved for XCT inspection. It could be a document that will be added to over time. It should be a best practice guidance document for persons and organisations to reference.

GL stated there was a question submitted to the Board for consideration regarding possible approvals for Film / Non-Film CRT, and would an Approved Training Organisation / Outside Agency have to be subjected to an additional audit process / re-audit/re-approval to have CRT added to their scope of approval. The question was asked do the Board want to go to the level of sub-techniques for approval or are they happy to leave as film/film less.

AP stated that if there are big differences then the board would have to consider the introduction of sub-techniques, and additionally, who would be considered suitable to carry out the training, who

would supply and master appropriate specimens, authorise the training process or authorise equipment for use in just even starting to think about the process.

It was agreed that further discussion should take place in order to establish what a conversion course looks like.

It was intimated that by October NADCAP could possibly have put something together as a suitable framework for this although would the NANDTB run the risk of forming a discrepancy?

- Further discussion asked who the right group or person would be to approach, (RR James Wilcox?). and within EN4179 should CT be classified as a technique in its own right answer yes.
- Do you require a digital RT approval before you can be considered a suitable candidate for CT

 answer yes.
- Could Training be provided at an equipment manufacturer or at a 3rd party premises and not the ATO/OA premises who may have no facilities?
- Should the approval to carry out training and examinations be on the scope of approval,
 currently there are no criteria or set of auditors capable of carrying out the required audit tasks. This should be a consideration.

MC stated that it is being raised as an issue through their customer base, and that they are currently developing a syllabus and training package in preparation for future use as they are aware of more than one client who intend to move forward with CT. Theory training could be provided through an OA working in conjunction with an OEM to provide a base for candidates moving forward. This could be seen to be a logical approach which would allow for additional requirements to be flowed down from NADCAP or Primes. ST is straight forward; however, it is the practical aspect that needs to be discussed. At the moment there is insufficient data not enough data for AM components and their associated flaws.

Discussion taking place regarding the above.

Next steps – separate meeting just about this. Face to face meeting in a room much easier for people to understand.

Thursday afternoon after Aerospace event – an hour for people to discuss Thursday 7th April. Invite only.

Separate issue before the Aero event but meeting needs to take place prior to this.

Put an hour in the diary for discussion and put together aims and objectives.
