

#### **REQUIRMENTS TO BE AN AEC**

PROSPECTIVE AND EXISTING APPROVED AECS SHALL COMPLY WITH THE EXAMINATION CONDITIONS SPECIFIED IN THIS DOCUMENT.

ACTUAL DEMONSTRATION OF COMPLIANCE IS A PREREQUISITE TO THE AWARD OF ANY APPROVAL. THE PROSPECTIVE AEC WILL INDICATE AN INTENTION TO COMPLY WITH THESE REQUIREMENTS BY COMPLETING THE ATTACHED APPLICATION FORM AND INCLUDING PSL/62-CM AND PSL/63-CM INTO THEIR QMS DOCUMENTATION.

#### **EXAMINATION CONDITIONS**

The AEC will ensure that the examination conditions provided are conducive to the conduct of PCN examinations. In the event that an examination area fails to comply with this provision, the AEC will immediately notify BINDT Certification Services to allow adequate notification to candidates and possible change of venue. In particular, the AEC must ensure that:

- 1. The examination room is fit for purpose and does not suffer from interferences (e.g. noise, dust etc);
- 2. The level of lighting, including ambient light, is satisfactory for the purpose<sup>1</sup>;
- 3. The examination room temperature is in the range 20 to 26°C<sup>2</sup>;
- 4. There are sufficient examination desks available, spaced no less than 1 metre apart;;
- 5. A clock or timer is available and visible by the invigilator and candidates;
- 6. Drinking water is available to candidates and invigilator;
- 7. Candidate's have access to toilet facilities;
- 8. Candidates have access to a waiting area;
- 9. Adherence to any additional conditions specified in PSL/62-CM for invigilators

### **PROCEDURE**

- A1. Upon receipt of an application, BINDT will request photographic evidence of the AEC (photographs should include the above listed requirements), an evaluation of the facilities specified by the AEC as the examination area and the company's QMS will be undertaken to verify compliance to PSL/63-CM and PSL/62-CM (if applicable); both documents should be specified in the QMS.
- A2. Existing PCN NDT AQBs/ATOs are exempt this AEC evaluation of facilities as they are subject to yearly surveillance audit and reassessment audit every 3<sup>rd</sup> year under their AQB/ATO agreement, but they must complete this document and PSL/62-CM for invigilators of CM examinations.
- A3. If an existing PCN NDT AQB fails their CP9 audit then their CM AEC rights will lapse until corrective actions are cleared and approved.
- A4. If an existing PCN NDT AQB ceases operations as an AQB then their CM AEC registration will cease.
- A5. BINDT must be advised immediately of any change in the personnel identified as being responsible for the provision of the examination facilities or services or any change in conditions.
- A6. Continued approval depends upon the organisation being found to comply with requirements during examinations.
- A7. Minor deficiencies must be corrected by the AEC before further examinations are undertaken at that facility.
- A8. Representatives of the BINDT shall have access to an approved AEC at all reasonable times to verify any aspect of its operation applicable to the requirements.
- A9. BINDT reserves the right to withdraw any AEC approval, wholly or in part, at any time.
