## **NAndtB/02 – AIMS AND OBJECTIVES**

The United Kingdom National Aerospace NDT Board has agreed the following aims and objectives.

The Board will:

1. Fulfill the United Kingdom requirements for a National Aerospace NDT Board as mandated by EASA part 145, CAA CAP747 GR23 as defined by EN4179.
2. Act as custodians for all matters relating to employer based certification within the UK aerospace sector.
3. Provide support and guidance to Employers and Responsible Level 3s required to comply with EN4179.
4. Control NDT personnel training and examinations through oversight of a third party audit and approval program
5. Where necessary, establish specific United Kingdom policy with regard to implementation of EN4179 requirements.
6. Establish policy and process for qualifying NDT personnel in new and emerging NDT technologies.
7. Provide a mechanism for interpretation, adjudication and arbitration in cases of dispute regarding EN4179 and United Kingdom National Aerospace NDT Board policy and procedures.
8. Seek recognition of its policies and procedures via the Aerospace NDT Board Forum with other National Aerospace NDT Boards, and with any other pertinent bodies in order to benefit the United Kingdom industry.
9. Recognise qualification of personnel achieved under the control of other National Aerospace NDT Boards who are members of the Aerospace NDT Board Forum.
10. Be a member of the Aerospace NDT Board Forum and comply with ANDTBF\_08.
11. Provide guidance to the Aviation Authorities with regard to regulation pertaining to NDT personnel certification
